A30/A35 Exeter to Bere Regis Trunk Road Maintenance

SWH/BBIS is the Managing Agent Contractor for Connect A30/A35 Limited, the concessionaire responsible for the operation and maintenance of the A30 and A35 between Exeter and Bere Regis.

As part of the maintenance strategy for the A30/A35, it is necessary to carry out some carriageway repairs and surface treatment works on the A35 between Honiton and Bere Regis.

The carriageway repairs will be carried out overnight, using road closures.

The closures will be used to facilitate all the required repair and surface treatment works and will also be used to carry out as many routine maintenance activities (sign cleaning, road sweeping etc.) as possible. This will mean that the requirement for further traffic management along the A35 will be minimised for the remainder of the year.

We have tried to minimise disruption to road users and residents by restricting our works to night time only. Where operations are carried out close to properties we will endeavour to undertake as much of any noisy activities before midnight. However work will continue through the night and some disruption may occur throughout the work period.

For all the road closures a fully signed traffic diversion route will be implemented during the closure periods.

During the closure periods access will be maintained for residents living within the closure. However, this may only be from one direction depending on the actual location of the works to be undertaken each shift, and may change where the closures are planned for consecutive nights.

Please note that during the closure period, some travel delays should be expected. We would suggest allowing extra time for your journey if an alternative or deferred travel arrangements cannot be made. During the closures there will be NO route through the works area for any vehicles with the exception of Emergency Service vehicles on emergency calls.

Additional information regarding access details for residents and businesses affected by these works will be available on request from connecta30@balfourbeatty.com.

Please note that the works planned are weather susceptible and may be subject to change due to circumstances beyond our control. We will endeavour to communicate any change in programme as soon as possible.

A dedicated phone line has been installed for customers who may wish to call and enquire about the closure. This number is for enquires regarding the road closure and associated diversion only.

We realise that these works may cause inconvenience to some local residents and roads users. We do however believe that the closures offer the most efficient and safest way to undertake these necessary works for residents along the route, the travelling public and our workers.

We would however like to take this opportunity to apologise if any inconvenience is caused during these operations.
